RESERVATION: A non-refundable deposit of US\$1000 is due with your reservation.

PAYMENTS: The deposit and other payments are to be made to Michelle Leske of Goddess Awakening Retreats. **Failure to pay in time entitles Goddess Awakening Retreats to cancel your booking without notice and without refund of the deposit.** Prices are quoted in US\$.

The Tour Price is based on a **minimum of 10 participants**. Should the required minimum number not be met, there may be a slight increase in the price. Participants that have confirmed a booking, will be notified of a price increase in advance.



Cancellation Policy:

If you need to cancel a reservation, please do so in writing by e-mail. If we receive your cancellation more than 45 days before the starting date of the trip, we refund 100% of your monies paid excluding the US\$1000 deposit.

Should you cancel:

45 days prior to the commencement of the tour – 70% of the Tour Cost will be non-refundable

44 – 32 days prior to the commencement of the tour – 85% of the Tour Cost will be non-refundable

30 – 0 days prior to the commencement of the tour – 100% of the Tour Cost will be non-refundable

The tour price is quoted as a package. No partial refunds or credit will be given for services not used. We recommend that you obtain travel insurance upon booking.

EXCLUSION FROM TOUR PRICE: The following items are **not** included in the tour price:

- *International Flights
- *Travel Insurance - Compulsory
